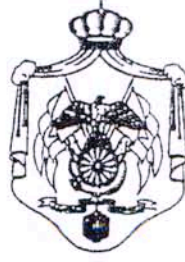

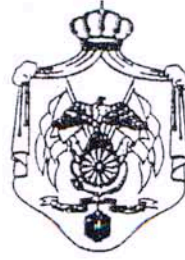
New agenda item 4: the full implementation of Resolution XI of the 1921 International Conference, in particular in occupied territories.

New agenda item 7: Implementation of the Memorandum of Understanding (MOU) and the Agreements on Operational Arrangements of 28 November 2005 in the Occupied Palestinian Territory.

New agenda item 8: The implementation of the ICRC Report on the urgent health and sanitary needs in the Occupied Syrian Golan by establishing the hospital and maternity unit and providing them with the necessary ambulances, to be linked to the ICRC in Geneva under the emblem of the Syrian Red Crescent.
