

**Annex 2:****Summary list of the Statutes-related situation of each National Society**  
**(updated as of 15 August 2007)**

Within the framework of Action 3 of the Strategy for the Movement updated by the Council of Delegates in November 2005, the Joint Statutes Commission drew up a list in September 2004 summarizing the Statutes-related situation of each National Society to the best of the Commission's knowledge. This list serves to thoroughly assess the extent to which the commitments made by the National Societies regarding revision of their Statutes have been carried out.

The first version of the list was enclosed with the letter sent to all National Societies on 25 September 2004. An updated version also accompanied the Joint Statutes Commission's report submitted to the Council of Delegates in November 2005. This present version of the list is updated as of 15 August 2007.

The previous versions of the list had five categories of National Societies, categorized according to the extent to which they had achieved the objective of examining their Statutes and amending them where needed. The new list enclosed (updated as of 15 August 2007) also has five categories, but the Joint Statutes Commission felt it important to refine the criteria. The new categories are defined as follows:

1. The first category has not changed. It is made up of National Societies whose Statutes are in accordance with the minimum requirements of the *Guidance document*. The Joint Statutes Commission congratulates them on laying this indispensable basis for effective operations. A new column (the ninth and final one) has nevertheless been added to the list to encourage the National Societies in this category that have not already done so to send to the Joint Statutes Commission a copy of their adopted Statutes.
2. This category is for National Societies in which the revision process is under way. These may be:
  - i) Societies that have officially notified the Joint Statutes Commission that the process has begun;
  - ii) Societies that have submitted draft Statutes to the Commission but which the Commission has not yet had time to study;
  - iii) Societies that have recently received recommendations from the Commission and have not yet responded to them.
3. This category corresponds to former category 4. It is for National Societies that have received the Joint Statutes Commission's views on their draft Statutes but have not responded to those recommendations. The Commission has decided that if six months go by with no response from the National Society after the sending of its recommendations, the Society's category will be altered from 2 (under way) to 3. The Commission therefore encourages the Societies in category 3 to indicate what progress they have made in the revision process.
4. This category is for those National Societies for which the Joint Statutes Commission has not been officially informed that the process of revising their Statutes required by the Strategy for the Movement has been undertaken. The Commission strongly encourages these Societies to begin the process and meet their obligations to examine and, where necessary, revise their statutes, and to keep the Commission informed of the progress so that it can aid in the process.

5. This category remains the same: National Societies that have received recommendations from the Joint Statutes Commission but have nevertheless adopted new Statutes without taking into sufficient account those recommendations. The resulting Statutes therefore fail to meet the minimum requirements of the *Guidance document*. The Commission regrets this situation and reminds the Societies concerned that the relevant ICRC and International Federation delegations stand ready to help them rectify this situation, as does the Commission itself.
- \* An asterisk indicates that the Joint Statutes Commission is not in a position to attribute a precise category (1-5) to a National Society. This corresponds to the two following situations:
- i) the Joint Statutes Commission provided comments on draft Statutes, which did not fully meet the minimum requirements of the *Guidance document*. The Commission knows that the Statutes were subsequently adopted, but has not received the adopted text. It is thus not possible for the Commission to assign a category to the National Society in question. In those rare cases, the column "Actions required" indicates what should be done in order to clarify the situation;
  - ii) the Joint Statutes Commission has received Statutes that have already been adopted. The Commission was not consulted on the draft and has not yet had the time to examine these adopted Statutes and to send its recommendations.

The enclosed summary list contains two new columns. The eighth column, entitled "Comments on the revision process", enables the Joint Statutes Commission to highlight the particular efforts being made by National Societies in the revision process, for example by indicating the dates of letters exchanged between the Commission and the Societies. The ninth and final column, entitled "Actions required," sets out either what the Commission expects from the Society (for example sending the Commission a copy of the newly adopted Statutes) or what the Society may expect from the Commission (for example, preparation under way of a letter from the Commission).

- Column 1:** National Society (NS) - **short name for the NS**

- Column 3:** Latest draft Statutes received by the Joint Statutes Commission (JSC) - **date of the latest draft version received after the adoption of the *Guidance document***
- Column 4:** Do the latest draft Statutes comply with the minimum requirements of the *Guidance document*? (Date of latest JSC letter)
- Yes - **date of the latest JSC letter indicating that the draft (or adopted) Statutes comply with the minimum requirements of the *Guidance document***
  - No - **date of the latest JSC letter indicating that the draft (or adopted) Statutes do not comply with the minimum requirements of the *Guidance document***
- Column 5:** Revised Statutes
- Adopted by NS? - **indicates whether the draft Statutes have been adopted (Yes or No) and the date of adoption**
  - Received by JSC? - **indicates whether the adopted Statutes have been received by the JSC (Yes or No) and the date of reception**
- Column 6:** Statutes in force - **date of the Statutes currently in force**
- Column 7:** Category as of 15 August 2007 - **assigns a category (1-5) to the status of the NS Statutes revision process towards the 2010 goal under Action 3, Strategy for the Movement**
- Column 8:** Comments on the revision process - **acknowledges the work done on Statutes revision by indicating the letters sent and received and indicates if the categories attributed under column 7 need to be confirmed (e.g. upon reception of the adopted Statutes)**
- Column 9:** Action required - **indicates the action required by either the NS or the JSC**
